(b) Any payment or provision of any other financial benefit (other than from the authority) made or provided within the relevant period in respect of any expenses incurred by me in carrying out duties as a Member, or towards my election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

PART B - NON-PECUNIARY INTERESTS

The following **Non-Pecuniary** interests of myself.

(a) Bodies to which I am appointed or nominated by the authority (ie outside body appointments).

(b) Bodies exercising functions of a public nature of which I am a Member (including regional and local development agencies, other (parish) Councils, public health bodies, school governing bodies).

* Body in which any of the above named persons has a beneficial interest means a firm in which any of the above named persons is a partner or a body corporate of which any of the above named persons is a director, or in the securities of which any of the above named persons has a beneficial interest.

(d) Any beneficial interest in land which is within the area of the authority.
