# Town Hall Project Action Plan June 2023 to October 2023

Please note that the below is subject to change, following the meeting on Thursday 29<sup>th</sup> June, which will include further discussion about the action plan and advice from the Project Manager and Town Clerk.

# 1. Thursday 29<sup>th</sup> June 2023

## **Town Hall Advisory Working Group**

To consider next steps, architect recommendations, non-councillor working group membership, business planning, consultation, business planning, etc. and make recommendations for Full Council to consider. Also consider the possibility of an extra meeting in August (see below)

### 2. Monday 10th July 2023

#### **Full Council**

Full Council to consider and make resolutions based on the Advisory Group recommendations. The main aspect to consider, being the appointment of two architectural companies to provide initial designs ideas, etc.

## 3. Thursday 27th July 2023

## **Town Hall Advisory Working Group**

To consider any matters that may need addressing and view preliminary architect designs (should they be available).

## 4. Monday 14th August 2023

#### **Extra Full Council Meeting**

For Councillor to view architectural designs and ideas for the first time. This meeting could also include an element on public consultation. Due to how important this decision is, a final design will not be chosen, but Council will select one of the two architects to proceed with the next level of plans and give them feedback.

### 5. Monday 11th September 2023

# **Full Council**

Consider more detailed and specific designs from the final architect and make any further suggestions and recommendations.

## 6. Thursday 21st September 2023

### **Town Hall Advisory Working Group**

To consider any matters that may need addressing, with particular focus on funding.

#### 7. Monday 23rd October 2023

### **Full Council**

Approve final architectural designs to enable the Project Manager to start costing the project more precisely.
